BY THE AUTHORITY: On December 16, 2011, Randolph Telephone Membership Corporation ("Randolph TMC"), Surry Telephone Membership Corporation ("Surry TMC"), Yadkin Valley Telephone Membership Corporation ("Yadkin Valley TMC"), and New Cingular Wireless PCS, LLC, and its Commercial Mobile Radio Service affiliates in North Carolina, formerly d/b/a Cingular Wireless, now d/b/a AT&T Mobility, (the "Parties") filed a Joint Motion to Dismiss with Prejudice all claims asserted against each in the above-captioned matters. In support of their Joint Motion, the Parties stated that they had resolved all disputes and executed binding settlement agreements.

Based on the Joint Motion to Dismiss with Prejudice and the submission of the above-referenced settlement agreements, the Authority hereby ORDERS as follows:

- 1. The agreements filed on December 16, 2011, and referenced in the first paragraph of this Order between Randolph TMC and New Cingular Wireless PCS, LLC d/b/a AT&T Mobility; Surry TMC and New Cingular Wireless PCS, LLC d/b/a AT&T Mobility and Yadkin Valley TMC and New Cingular Wireless PCS, LLC d/b/a AT&T Mobility are herby approved effective on the dates as shown in the agreements.
- 2. All claims asserted against Randolph TMC, Surry TMC, Yadkin Valley TMC, and New Cingular Wireless PCS, LLC, and its Commercial Mobile Radio Service affiliates in North Carolina, formerly d/b/a Cingular Wireless, now d/b/a AT&T Mobility in the above-captioned matters are DISMISSED with Prejudice; and

3. The Petitions of Randolph TMC, Surry TMC and Yadkin Valley TMC for Arbitration Pursuant to 47 USC § 252 Interconnection Agreements with New Cingular Wireless PCS, LLC, formerly d/b/a Cingular Wireless, now d/b/a AT&T Mobility are CLOSED.

IT IS HEREBY ORDERED.
